I am deeply committed to product safety and dedicated to enhancing the lash industry I hold in high regard by offering secure and cost-effective lash liquids and glues manufactured in the UK.

Since 2014, my mission has been to shed light on the realities of an unregulated beauty sector and the potential harm it poses, not only to the well-being of lash artists, but also to their clientele.

Advocating for product safety, I draw from personal experiences to educate lash artists on comprehending the components present in their lash products, empowering them to make informed and safe selections.

In an unregulated lash industry, the accessibility of harmful lash products to anyone is concerning. Regrettably, many lash suppliers rely on manufacturers with an assumption of safety in their products. However, lacking expertise in ingredients and their health implications, numerous lash retailers unknowingly distribute products containing substandard or even prohibited substances.

Even prominent brands inadvertently offer lash liquids and glues that contain inferior ingredients, detrimental to the health of individuals exposed to them over time.

Having personally encountered this issue, I embarked on a quest in 2014 to identify safe lash products and reveal the dark side of our unregulated lash industry.



My Story

In 2014 and at the same time of introducing my range of lash products, my health had started to suffer but seemed worse when I was lashing.

As a naturally healthy person it was unusual for me to feel so sick. My symptoms started with extreme headaches, sinus pain, light sensitivity, a constant runny nose, black mucus, chesty cough, cold like symptoms, fatigue and itchy skin on my face, neck and chest.

I had to start wearing a mask when lashing to catch the mucus from my runny nose and I found this helped to reduce my headaches some what, but I was still feeling unusually sick and it was always the lashing that triggered it.

I assumed I was overworked (I was working long days) hence the fatigue, the “run down” cold like symptoms and the sensitivity to my lash light.

Visits to the doctors failed to shed light on my ill health so for several months I continued to suffer, hoping that I would get better.

Then one day the penny dropped.. it was the lashing that was the issue! It seems so obvious now, but back then I had no idea it could be the cause.

It was from this day that I started on my journey to understand the real truth of the lash industry. I had been unknowingly exposing myself to lash products (namely the adhesives) which were destroying my health. These products were non beauty grade, low quality, industrial strength products being used in the lash industry and super close to the eyes, other mucus membranes and the respiratory tract. I wondered how such harmful products could be sold to lash artists and this is when I learned that there was no global regulation policing the safe production of lash liquids. This meant that low grade ingredients were able to be used in our lash products and sold anywhere in the world with zero consequences.

Even in the UK where I live and where we are seen to have some of the strictest regulations in the world, there was no governing body controlling the import of products into the country that could be harmful. I was shocked and wondered how many lash artists were suffering like I was.

Sadly my health was getting worse as I continued to expose myself to these products. I also had no choice, lashing was how I earned my money and without my job I could not earn and I could not live. This is when I knew I had to try to find an alternative way/product which would allow me to lash and this is where my journey started into creating my own brand of UK lash glues and liquids which would allow me to lash again.

To start, I was focusing on just the glues being the issue, but as I continued to learn about our lash products, I also realised that all liquid products are ingested into the body therefore if they contain low grade products they too will affect your health. So although I had blamed the glue, I had overlooked the other lash liquid products I had been ingesting and therefore why I needed a full range of UK made lash liquids to ensure that what I was exposing myself to was safe.

Nine years later, I continue to advocate for educating lash artists about the truth behind the products we use. It appears that lash artists are now beginning to grasp the importance of this matter. With a growing number of allergic reactions among lash artists and clients, many are recognising that my concerns are not unfounded but are indeed valid.

Due to the safety of my lash products, I am continuously approached by lash suppliers who would love to offer their client base Eyelash Excellence products who's quality and safety they can trust.

The truth about our lash liquid ingredients

The Far East is one of the biggest producers of global products including beauty products such as lash glues and liquids. The cheap production costs associated with these countries are due to many factors:

- Abundance of cheap labor
- Low grade ingredients used
- Lack of regulatory compliance/healthy & safety etc
- Low taxes and duties
- Competitive currency

From these reasons we can see why our lash products are manufactured there and how they can be produced at such low costs. It is these super cheap prices which attract lash suppliers who can then make high profits.

The facts

Did you know that most lash liquids are able to be purchased direct from the Far East from as little as \$1? But ask yourself this.. can a product that is retailed for such a low price really contain high grade quality ingredients that are safe to be ingested by the human body?

This \$1 covers the price of the product inside the bottle, the bottle, lid, labelling, labor etc and yet for \$1 they are still making a profit.

Again ask yourself, for such a low price can the quality of the product inside really be any good? The answer is 'No!' However, in an unregulated industry, who is going to stop this from happening?

Why do we only manufacture our lash liquids in the UK/EU?

There are several compelling reasons to prioritise purchasing lash products manufactured in the UK and EU over cheaper alternatives from countries like China or the Far East:

Over the years I have frequently been approached about the possibility of offering our products on a wholesale basis. It became evident that there was a significant demand for our top-notch lash products, particularly our best-selling UK-manufactured lash liquids and adhesives.

Recognising this demand, I made the decision to extend our product offerings to not only accommodate busy salons but also cater to those seeking discounted prices for resale purposes, allowing them to capitalise on the opportunity to generate profits.

Our Wholesale programme provides lash suppliers the option of buying our well known trusted lash products directly from us at a discounted price and selling to their customers for a higher price, which is how wholesalers make their profit.

Our Wholesalers may specialise in a single product only or chose from our variety of lash products we offer.

A wholesaler should not be confused with an "official distributor" for our brands product line. They simply purchase our products at a discounted price and sell for a higher price.

Can I sell your products for more than you sell on your website?

Yes, and we highly recommend considering this option. Presently, our distribution network operates solely within the UK, which results in higher shipping expenses for international customers. However, we exclusively offer wholesale opportunities to suppliers located outside of the UK. Consequently, customers who purchase from our wholesalers can benefit from reduced shipping fees. They may leverage this advantage by adjusting their product pricing accordingly.

Have any of these products ever been subject to animal testing in any way?

We have never tested and will never test on animals, and we make sure any suppliers we use are cruelty-free too.

Do I need any additional Safety Assessments for your products?

We have all the correct CPSRs (Cosmetic Product Safety Report) in place for our lash liquids and adhesives, as well as Material Safety Data Sheets. This means you can re-sell our products with 100% confidence that what you are selling is safe. However due to different International regulations, it is the responsibility of the wholesaler to understand and conform to any regulations set by their own country.

What is a MSDS (Material Data Safety sheet) and do I need them?

It is a comprehensive document that provides detailed information about the properties, hazards, handling, storage, and emergency measures related to a specific chemical substance or product.

Can I get copies of the MSDS.

MSDS are available on request for your customers.

Where are your ingredients from?

We ONLY use quality premium ingredients from the industry leading manufacturers in Europe and the UK. You can ensure that the quality of our products are the best in the world due to the quality and passion that goes into producing our lash liquids and adhesives.

Are there any exclusivity agreements or territories for wholesale distribution?

We reserve the right to decline applications based on the geographic locations of wholesalers. Our goal is to maintain fairness among sellers and prevent over-saturation of specific areas with Eyelash Excellence wholesalers.

Do you require wholesalers to sign a contract or agreement?

No, however by purchasing from Eyelash Excellence, you agree to the terms and conditions outlined which can be found at the end of the catalogue.

What is the process for resolving disputes or issues with wholesale orders?

Complaints regarding Eyelash Excellence products must be submitted to us and in writing within 3 business days. We will investigate the complaint promptly and provide a response within 3 business days. If the complaint is found to be valid, we will take appropriate action to rectify the issue, which may include replacement of the product or issuance of a refund. We may request additional information or evidence to assist in the investigation of the complaint.

FAQs

What is the MOQ? (minimum order quantity)

There is no MOQ per product, however to qualify for our programme a total spend of £600 is required to be accepted as a wholesale customer.

What is your production and delivery times.

Production and delivery times for products vary depending on order quantity and whether we have the products in stock or if they require manufacturing. Manufactured liquid products are approximately 6 weeks from the time of payment to goods being shipped from the UK. Tweezers can vary from a 4 -12 week lead time, again depending on our current stock levels or whether they require manufacturing. Your goods will leave us either the same day or next day, via our express shipping DHL carrier which aims to deliver world wide within 3-5 business days. DHL states that the time frames given for delivery are given as a guide. They aim to deliver within these time frames - and the majority of the time they do. However, there are a small number of cases (for example, if you live in a remote area) that the shipments will take a little longer than the stated days. We at Eyelash Excellence cannot be held accountable for these delays and DHL will keep you notified on any tracking or updates regarding your delivery. Our Cyanoacrylate is manufactured on-site in its purest form, unlike other adhesive producers who purchase it elsewhere and do not refine it to beauty grade.

All our lash adhesives, along with our liquid products, are freshly made and shipped to us either the same day or the next day. For products ordered that are in stock and do not need to be manufactured, we hold only for 4 weeks, to ensure freshness of stock.

To maintain quality control, our adhesives are sealed to prevent moisture intrusion before opening with the provided pin.



ACCEPTANCE OF THE GOODS & COMPLAINTS
